

Terms and Conditions for the Elders Autumn Catalogue 2019

1. The Elders Catalogue (**Campaign**) commences on 8:30am on the 4 March 2019 and closes at 5pm on the 26 April 2019.
2. To be eligible to receive a bonus under the Campaign, an entrant must:
