

Terms and Conditions for the Elders “Spring” Catalogue 2019

General

1. These terms and conditions (“**Terms**”) apply to bonuses available in the Elders Spring Catalogue 2019 (“**Catalogue**”) which commences 12 August and ends 27 September 2019, unless otherwise specified by Suppliers.
2. To be eligible for a bonus in the Catalogue, you must:
 - a. be a resident of Australia;
 - b. have received, from the Elders branch at which you have purchased a product listed in the Catalogue to which a bonus applies and a tax invoice.
3. Employees of Elders, and their immediate families, associated companies and agencies and suppliers involved in the Catalogue are ineligible for any bonuses or Elders Dollars available in the Catalogue.
4. The bonuses set out in the Catalogue apply to the relevant products described in the Catalogue while stocks last, and may be subject to a product supplier’s separate terms and conditions.
5. The bonuses in this Catalogue (which includes Elders Dollars) cannot be transferred or redeemed for cash.
6. Purchases of products to which bonuses apply must occur in one transaction and appear on one tax invoice.
7. Elders may, in its discretion, make any changes it deems necessary to these Terms, including changes to:
 - a. the range of products to which bonuses apply;
 - b. the bonus applicable to any particular product;
 - c. the period in which the bonus applies; and
 - d. the period in which a bonus can be redeemed.

Elders will provide you with notice of any changes to these Terms via its website (www.elders.com.au) and/or by direct communication to you.

8. Where you are required to complete any documentation to be eligible for a bonus (or Elders does so on your behalf), Elders and its employees, agents or contractors are not liable to you for any lost, illegible, misdirected, incomplete or damaged documentation.
9. Elders does not exclude or limit the application of any provision of any applicable legislation or other regulation (including the Competition and Consumer Act 2010 (Cth)) where to do so would contravene that legislation or regulation or cause any part of these Terms to be void. Nothing in these Terms is to be interpreted as doing so.
10. Subject always to clause 9, to the extent permitted by law, Elders excludes from these Terms:
 - a. all conditions, warranties, guarantees and terms implied by statute, general law, international convention or custom, except any implied term, condition, guarantee or warranty the exclusion of which would contravene any statute or cause this clause to be void (“**Non-excludable Condition**”);
 - b. all liability to you for direct, consequential or indirect loss or damages arising out of or in connection with these Terms or the Catalogue, even if Elders knew they were possible, or they were otherwise reasonably foreseeable, and including without limitation, loss of profits and damage suffered as a result of claims by any third person; and
 - c. all liability to you in negligence for acts or omissions of Elders, its employees, agents and contractors arising out of or in connection with these Terms or the Catalogue.
11. To the fullest extent permitted by law, the liability of Elders to you for breach of any Non-excludable Condition which is applicable is limited to any one of the following, at the option of Elders:
 - a. in the case of goods, replacement of the goods or the supply of equivalent goods, repair of the goods, payment of the cost of replacing the goods or acquiring equivalent goods, or payment of the costs of having the goods repaired;
 - b. in the case of services, the supply of the services again or payment of the cost of having the services supplied again; and
 - c. in the case of any bonuses, the provision of that bonus to you.



12. Any issues relating to your eligibility for any bonuses will be managed in the first instance by your local Elders Branch Manager and the relevant supplier (if applicable).
13. You are liable for any taxes, duties, delivery fees or other applicable charges that may be due and payable, for whatever reason resulting from you purchasing any products in the Catalogue or receiving any bonuses.

15. Any dispute arising out of or in relation to this Catalogue or any bonuses available in it shall be governed by the laws of South Australia.

17. For the purpose of these Terms, "Eligible Products" were those products listed in the Catalogue as being eligible to earn Elders Dollars.
18. To earn Elders Dollars, Eligible Products were to be purchased in-store from Elders using a current Elders credit account.
19. Elders Dollars are GST inclusive.
20. Elders may reverse your earning of Elders Dollars where a transaction for Eligible Products is cancelled or a refund is given.
21. Elders may correct incorrectly accounted Elders Dollars or adjust the balance of your Elders Dollars at any time, even if it would result in you holding a negative balance of Elders Dollars. A negative Elders Dollars balance is recoverable from you as a debt.
22. You can check the balance of your Elders Dollars by contacting your local Elders branch.
23. Elders Dollars can be used in your participating Elders branch to purchase farm supplies retail products only (excluding agency products), from 1 August to 30 September 2019.
24. Elders Dollars cannot be sold or given to anyone else, and have no cash or monetary value.
25. The total balance of your Elders Dollars must be used in a single transaction with Elders.
26. Any unused portion of Elders Dollars will be forfeited to Elders.
